# Mayor Arthur J. Holland Papers Trenton Council on Human Relations

# **Biography**

Arthur John Holland (24 October 1918 – 9 November 1989) was born in Trenton, and was mayor of the city 1959-1966 and 1970-1989 (his death). He had studied to become a priest, but instead attended St. Francis College in New York and then Rutgers University. In 1951, he became deputy director of public affairs for Trenton, and was elected on the Democratic ticket to the city council in 1955. He became mayor in 1959.

In 1964, he moved into the Mill Hill section of Trenton, which at that time was a majority African-American neighborhood, in a public attempt to lead the way for racial integration in the city. The move received national attention, much of it negative.

Holland lost the Democratic primary to Carmen J. Armenti in 1966. After teaching at Rutgers University for four years, he ran for mayor again and was reelected in 1970, serving until his death in 1989. He was president of the United States Conference of Mayors from 1988 to 1989, and died at Trenton's St. Francis Medical Center.

The Trenton Committee on Unity was organized in 1943 as a grassroots organization apart from city government. By the late 1940s, it had changed its name to the Trenton Council on Human Relations and continued into the period of time that Holland was mayor.

## Scope and Content Notes

These boxes are believed to have originated with the bulk of the collection that is now known simply as The Holland Papers. At some point, these files were separated and placed together in boxes and given names. Some of the papers are in their original folders, while others have been refoldered. Original order is unknown, and the boxes do not necessarily follow a pattern. The papers have not been fully processed and some of the boxes are not full. Students from the history department at The College of New Jersey created a basic inventory of the folders in each box.

This collection contains 4 record-sized storage boxes, numbered 3-6, that for some reason were separated from the other collection of papers in the Trenton Committee on Unity / Trenton

Council on Human Relations boxes. It is unknown at this time if boxes 1-2 exist or if their contents are now part of the Trenton Committee on Unity collection.

The papers of Mayor Arthur J. Holland are significant in documenting the actions of a city politician during a significant period of civil, racial, and economic unrest in a large urban community and state capital. Subjects of interest to researchers include community and civic organizations in Trenton, civil rights activism in the 1960s, housing, and urban redevelopment and renewal.

#### Provenance

Holland's wife Betty, whom he married in the early 1960s, donated these papers. Committee on Unity boxes may have come from another source.
